AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2, DIVISION 3 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 102.0304 RELATING TO PARCEL MAP FEES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 2, Division 3 of the San Diego Municipal Code, be, and it is hereby amended by amending Section 102.0304 to read as follows:

SEC. 102.0304 PARCEL MAP PROCESSING FEE

A fee of \$200.00 shall accompany each parcel map when submitted to the City Engineer; provided, however, that when a parcel map is determined by the City Engineer to be of a nonroutine nature, he may require a deposit and process the parcel map on the basis of actual costs.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
