ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING PROPERTY IN THE LA JOLLA COMMUNITY PLAN AREA GENERALLY BOUNDED ON THE NORTHWEST-BY VIRGINIA WAY AND TORREY PINES ROAD, ON THE NORTHEAST BY SIERRA MAR DRIVE AND HILLSIDE DRIVE, ON THE SOUTHEAST BY VIA VALVERDE AND LA JOLLA SCENIC DRIVE SOUTH, ON THE SOUTH BY NAUTILUS STREET, AND ON THE WEST BY GIRARD AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-8, R-1-10, R-1-20, AND R-1-40 ZONES AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13294, APPROVED AUGUST 31, 1931, ORDINANCE NO. 5398 (NEW SERIES), ADOPTED DECEMBER 4, 1952, ORDINANCE NO. 7344 (NEW SERIES), ADOPTED FEBRUARY 14, 1957, AND ORDINANCE NO. 7670 (NEW SERIES), ADOPTED DECEMBER 3, 1957, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the La Jolla Community Plan

Area generally bounded on the northwest by Virginia Way and Torrey

Pines Road, on the northeast by Sierra Mar Drive and Hillside

Drive, on the southeast by Via Valverde and La Jolla Scenic Drive

South, on the south by Nautilus Street, and on the west by Girard

Avenue, in the City of San Diego, California, within the boundary

of the district designated "R-1-8," "R-1-10," "R-1-20," and

"R-1-40" on Zone Map Drawing No.C-545.2 , filed in the office of

the City Clerk as Document No.761781 , be, and it is hereby

incorporated into R-1-8, R-1-10, R-1-20, and R-1-40 Zones, as

such zones are described and defined by Section 101.0407 of the

San Diego Municipal Code.

Section 2. That Ordinance No. 13294, approved August 31, 1931, Ordinance No. 5398 (New Series), adopted December 4, 1952,
