AN ORDINANCE INCORPORATING PROPERTY IN THE LA JOLLA COMMUNITY PLAN AREA, GENERALLY BOUNDED ON THE NORTH BY NAUTILUS STREET, ON THE EAST BY LA JOLLA MESA DRIVE AND RUTGERS ROAD, ON THE SOUTH BY VAN NUYS STREET, AND ON THE WEST BY FAY AVENUE AND BELLEVUE AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-40, R-1-10, AND R-1-8 ZONES AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13294, APPROVED AUGUST 31, 1931, ORDINANCE NO. 5398 (NEW SERIES), ADOPTED DECEMBER 4, 1952, AND ORDINANCE NO. 8211 (NEW SERIES), ADOPTED DECEMBER 10, 1959, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HERewith.

BE IT ORDAINED, by the Council of The City of San Diego
as follows:

Section 1. That property in the La Jolla Community Plan Area generally bounded on the north by Nautilus Street, on the east by La Jolla Mesa Drive and Rutgers Road, on the south by Van Nuys Street, and on the west by Fay Avenue and Bellevue Avenue, in the City of San Diego, California, within the boundary of the district designated "R-1-40," "R-1-10," and "R-1-8" on Zone Map Drawing No. C-546.2, filed in the office of the City Clerk as Document No. 761782, be, and it is hereby incorporated into R-1-40, R-1-10, and R-1-8 Zones, as such zones are described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13294, approved August 31, 1931, Ordinance No. 5398 (New Series), adopted December 4, 1952, and Ordinance No. 8211 (New Series), adopted December 10, 1959, of the ordinances of The City of San Diego, be, and they are hereby repealed insofar as they conflict herewith.
