AN ORDINANCE INCORPORATING A PORTION OF PUEBLO LOT 1298 LOCATED WITHIN THE UNIVERSITY OF CALIFORNIA -AT SAN DIEGO IN THE LA JOLLA COMMUNITY PLAN AREA, GENERALLY BOUNDED BY THE PACIFIC OCEAN ON THE WEST, EL PASEO GRANDE ON THE SOUTH, AND LA JOLLA SHORES DRIVE ON THE EAST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13294, APPROVED AUGUST 31, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Pueblo Lot 1298 located within the University of California at San Diego in the La Jolla Community Plan Area, generally bounded by the Pacific Ocean on the El Paseo Grande on the south, and La Jolla Shores Drive on the east, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. C-548.1, filed in the office of the City Clerk as Document No. 761072, be, and it is hereby incorporated into R-1-5 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13294, approved August 31, 1931, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
