AN ORDINANCE INCORPORATING PROPERTY NORTH OF COAST BOULEVARD BETWEEN ELLEN SCRIPPS COVE PARK AND GOLDFISH POINT IN THE LA JOLLA COMMUNITY PLAN AREA IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 AND CS ZONES AS DEFINED BY SECTIONS 101.0407 AND 101.0432, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7177 (NEW SERIES), ADOPTED OCTOBER 11, 1956, AND ORDINANCE NO. 9926 (NEW SERIES), ADOPTED DECEMBER 12, 1968, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property north of Coast Boulevard between Ellen Scripps Cove Park and Goldfish Point in the La Jolla Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-1-5" and "CS" on Zone Map Drawing No. C-548.1, filed in the office of the City Clerk as Document No. 761072, be, and it is hereby incorporated into R-1-5 and CS Zones, as such zones are described and defined by Sections 101.0407 and 101.0432, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 7177 (New Series), adopted October 11, 1956, and Ordinance No. 9926 (New Series), adopted December 12, 1968, be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
