## ORDINANCE NO. 12182 (New Series)

AN ORDINANCE INCORPORATING LOTS 2-6, COPLEY SUBDIVISION AND LOTS 8-10, BLOCK 24, LA JOLLA PARK, IN THE LA JOLLA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, INTO-R-3 ZONE AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13294, APPROVED AUGUST 31, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 2-6, Copley Subdivision and Lots 8-10, Block 24, La Jolla Park, in the La Jolla Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-549.1, filed in the office of the City Clerk as Document No. 761074, be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13294, approved August 31, 1931, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
