AN ORDINANCE INCORPORATING LOTS 46-54, BLOCK 1, AND LOTS 1-7 AND 18-26, BLOCK 6, LA JOLLA STRAND, IN THE LA JOLLA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO RV ZONE, AS DEFINED BY SECTION 101.0414 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9926 (NEW SERIES), ADOPTED DECEMBER 12, 1968 AND ORDINANCE NO. 11167 (NEW SERIES), ADOPTED NOVEMBER 27, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 46-54, Block 1, and Lots 1-7 and 18-26, Block 6, La Jolla Strand, in the La Jolla Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "RV" on Zone Map Drawing No. C-549-1, filed in the office of the City Clerk as Document No. 761074, be, and it is hereby incorporated into RV Zone, as such zone is described and defined by Section 101.0414 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9926 (New Series), adopted December 12, 1968, and Ordinance No. 11167 (New Series), adopted November 27, 1973, of the ordinances of The City of San Diego, be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
