AN ORDINANCE-INCORPORATING PROPERTY IN THE LA JOLLA COMMUNITY PLAN AREA GENERALLY BOUNDED ON THE NORTH BY KLINE STREET, ON THE EAST BY HERSCHEL AVENUE, ON THE SOUTH BY PEARL STREET, AND ON THE WEST BY CUVIER STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 AND CS ZONES, AS DEFINED BY SECTIONS 101.0411 AND 101.0432, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13294, APPROVED AUGUST 31, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the La Jolla Community Plan Area generally bounded on the north by Kline Street, on the east by Herschel Avenue, on the south by Pearl Street, and on the west by Cuvier Street, in the City of San Diego, California, within the boundary of the district designated "R-3" and "CS" on Zone Map Drawing No. C-550.1, filed in the office of the City Clerk as Document No. 761073, be, and it is hereby incorporated into R-3 and CS Zones, as such zones as described and defined by Sections 101.0411 and 101.0432, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 13294, approved August 31, 1931, of the ordinances of The City of San Diego, be, and is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
