AN ORDINANCE INCORPORATING PROPERTY IN THE SAN DIEGO RIVER FLOODPLAIN WHICH IS GENERALLY BOUNDED BY MORENA-BOULEVARD ON THE WEST, THE NORTHERLY SLOPES OF MISSION VALLEY ON THE NORTH, MISSION GORGE ROAD ON THE EAST, AND THE SOUTHERLY SLOPES OF MISSION VALLEY ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-40 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the San Diego River Floodplain which is generally bounded by Morena Boulevard on the west, the northerly slopes of Mission Valley on the north, Mission Gorge Road on the east, and the southerly slopes of Mission Valley on the south, in the City of San Diego, California, within the boundary of the district designated "R-1-40" on Zone Map Drawing C-524, filed in the office of the City Clerk as Document No. 761169, be, and it is hereby incorporated into R-1-40 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
