AN ORDINANCE AMENDING CHAPTER III, ARTICLE 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 34.03 RELATING TO BICYCLE LICENSE FEE

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 4, of the San Diego Municipal Code be and it is hereby amended by amending Section 34.03 to read as follows:

SEC. 34.03 BICYCLE LICENSE FEE

any bicycle and for the renewal of registration and licensing of any bicycle shall be two dollars (\$2.00); for registration and licensing when there is a transfer of ownership, the new owner shall pay one dollar (\$1.00) for the transfer of the license to his name; for a lost or destroyed license plate, a new license plate shall be issued for which the owner shall pay one dollar (\$1.00). All fees shall be paid in advance.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
