AN ORDINANCE INCORPORATING PORTIONS OF LOTS 2 AND 3 OF THE SUBDIVISION OF THE WEST 1/2 OF PUEBLO LOT 1215 (APPROXIMATELY 17,800 SQ. FT.), LOCATED EAST OF LINDA VISTA ROAD ADJACENT TO I-805 BETWEEN AERO DRIVE AND BALTIC STREET, IN THE CLAIREMONT MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS SUCH ZONE IS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13457, APPROVED FEBRUARY 15, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Portions of Lots 2 and 3 of the subdivision of the West 1/2 of Pueblo Lot 1215 (approximately 17,800 sg. ft.), located east of Linda Vista Road adjacent to I-805 between Aero Drive and Baltic Street, in the Clairemont Mesa Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3003, filed in the office of the City Clerk as Document No. 761705, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13457, approved February 15, 1932, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the



provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
