AN ORDINANCE INCORPORATING LOTS A-234, A-235, AND A-236, ADDITION NO. 5 OF SAN YSIDRO, LOCATED ON THE NORTH SIDE OF BLACKSHAW LANE BETWEEN AVERIL ROAD AND DAIRY MART ROAD, IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, AND ORDINANCE NO. 8139 (NEW SERIES), ADOPTED JULY 2, 1959, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Lots A-234, A-235, and A-236, Addition No. 5 of San Ysidro, located on the north side of Blackshaw Lane between Averil Road and Dairy Mart Road, in the San Ysidro Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. B-3011, filed in the office of the City Clerk as Document No. 761435, be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8028 (New Series), adopted December 18, 1958, and Ordinance No. 8139 (New Series), adopted July 2, 1959, of the ordinances of The City of San Diego, be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the


