AN ORDINANCE INCORPORATING THE PROPERTY KNOWN AS LEMON GARDEN ACRES (APPROXIMATELY 23 ACRES), LOCATED NORTH OF IMPERIAL AVENUE, WEST OF 47TH STREET, EAST OF 45TH STREET AND SOUTH OF K STREET AND THE SAN DIEGO AND ARIZONA EASTERN RAILROAD RIGHT-OF-WAY, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Property known as Lemon Garden Acres (approximately 23 acres), located north of Imperial Avenue, west of 47th Street, east of 45th Street and south of K Street and the San Diego and Arizona Eastern Railroad right-of-way, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing C-597.1, filed in the office of the City Clerk as Document No. 761737, be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
