AN ORDINANCE INCORPORATING A PARTITION OF RANCHO MISSION OF SAN DIEGO, S.C.C. NO. 348 (APPROXIMATELY 34 ACRES), LOCATED NORTH OF OLD MEMORY LANE, WEST OF 60TH STREET, EAST OF KELTON ROAD AND SOUTH OF STATE HIGHWAY 94, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-10 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a partition of Rancho Mission of San Diego, S.C.C. No. 348 (approximately 34 acres), located north of Old Memory Lane, west of 60th Street, east of Kelton Road and south of State Highway 94, in the Southeast San Diego Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R-1-10" on Zone Map Drawing No. C-596, filed in the office of the City Clerk as Document No. 761818, of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
