AN ORDINANCE INCORPORATING A PORTION OF LOT 63, PUEBLO VISTA UNIT NO. 4 (APPROXIMATELY 10,560 SQ. FT.), LOCATED ON THE NORTH SIDE OF MESA COLLEGE DRIVE BETWEEN ASHFORD STREET AND ARMSTRONG STREET, IN THE CLAIREMONT MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9010 (NEW SERIES), ADOPTED MAY 7, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. A portion of Lot 63, Pueblo Vista Unit No. 4, (approximately 10,560 sq. ft.), located on the north side of Mesa College Drive between Ashford Street and Armstrong Street, in the Clairemont Mesa Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. B-3024, filed in the office of the City Clerk as Document No. 761730, be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9010 (New Series), adopted May 7, 1964, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
