AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE AGREEMENT WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, A POLITICAL SUBDIVISION IN THE STATE OF CALIFORNIA, UNDER THE TERMS AND CONDITIONS OF THE LEASE AGREEMENT ON FILE WITH THE CITY CLERK'S OFFICE

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with THE SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, a political subdivision in the State of California, as Lessor, for the purposes of constructing, operating and maintaining the turfed playing fields on a portion of the Hardy Elementary School site, for a term of 25 years, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 762201.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
