AN ORDINANCE INCORPORATING 39 NET ACRES OF R-4 ZONED PROPERTY BOUNDED ON THE WEST BY I-5, ON THE NORTH BY HIGHWAY 94, ON THE EAST BY 25TH STREET, AND ON THE SOUTH BY EMPERIAL AVENUE, IN THE SOUTHEAST COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12942, APPROVED SEPTEMBER 4, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Thirty-nine (39) net acres of R-4 zoned property bounded on the west by I-5, on the north by Highway 94, on the east by 25th Street, and on the south by Imperial Avenue, in the Southeast Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-556.1, filed in the office of the City Clerk as Document No. 761736, be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12942, approved September 4, 1930, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
