ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING 129 ACRES OF R-4 ZONED PROPERTY BOUNDED ON THE WEST AND ON THE SOUTH BY I-5, ON THE NORTH BY COMMERCIAL STREET, AND ON THE EAST BY 28TH STREET, IN THE SOUTHEAST COMMUNITY PLAN AREA IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 AND R-2A ZONES, AS DEFINED BY SECTION NOS. 101.0409 AND 101.0410, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12942, APPROVED SEPTEMBER 4, 1930, OF THE ORDINANCES OF THE CITY OF

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

Section 1. One hundred twenty-nine (129) acres of R-4 zoned property bounded on the west and on the south by I-5, on the north by Commercial Street, and on the east by 28th Street, in the Southeast Community Plan Area in the City of San Diego, California, within the boundary of the district designated "R-2" and "R-2A" on Zone Map Drawing No. C-556.1, filed in the office of the City Clerk as Document No. 761636, be, and it is hereby incorporated into R-2 and R-2A Zones, as such zones are described and defined by Section 101.0409 and Section 101.0410, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12942, approved September 4, 1930, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
