ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING 180 ACRES OF R-4 ZONED PROPERTY BOUNDED ON THE WEST BY 28TH STREET, ON THE NORTH BY COMMERCIAL STREET, ON THE EAST BY HIGHWAY 15, AND ON THE SOUTH BY I-5, IN THE SOUTHEAST COMMUNITY PLAN AREA IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13216, APPROVED MAY 18, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. One hundred eighty (180) acres of R-4 zoned property bounded on the west by 28th Street, on the north by Commercial Street, on the east by Highway 15, and on the south by I-5, in the Southeast Community Plan Area in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. C-556.1, filed in the office of the City Clerk as Document No. 761636, be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13216, approved May 18, 1931, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
