AN ORDINANCE INCORPORATING PARCEL 2, PARCEL MAP 4774, BEING A PORTION OF LOT 1 OF MONTGOMERY PALISADES NEIGHBORHOOD SHOPPING CENTER (APPROXIMATELY 3.8 ACRES), LOCATED ON THE EAST SIDE OF BEYER WAY AND NORTH OF PALM AVENUE, IN THE PROPOSED OTAY-NESTOR COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8292 (NEW SERIES), ADOPTED APRIL 28, 1960, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel 2, Parcel Map 4774, being a portion of Lot 1 of Montgomery Palisades Neighborhood Shopping Center (approximately 3.8 acres), located on the east side of Beyer Way and north of Palm Avenue, in the proposed Otay-Nestor Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. B-3009, filed in the office of the City Clerk as Document No. 761496, be, and it is hereby incorporated into R-2A Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8292 (New Series), adepted.

April 28, 1960, of the ordinances of The City of San Diego, be,

and it is hereby repealed insofar as it conflicts herewith.
