WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

William Curry	Transportation	\$145	Mr. Curry is a Utility Worker I in the Streets Division. He suggested that an electronically controlled on and off switch be installed on the emulsion spray tank at Rose Canyon. This frees one Utility Worker I for other duties and saves the City an estimated \$1,466. In addition it makes the operation safer.
Arthur R. Shenk	Transportation	\$100	Mr. Shenk is an Electronic Technician in the Communications and Electrical Division. He suggested that electrical switches be installed in the radio and telephone equipment room in COB so that the lights can be turned off when not in use. This will save the City an estimated 24,142 kilowatt hours per year, or \$1,007.
