

RESOLUTION NO. 217430Adopted on JAN 5 1977

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Flavian R. Geis	Engineering and Development	\$75	Mr. Geis is an Intermediate Typist in the Subdivision Section. He suggested that copies of Invoice Statement Forms no longer be filed in file jackets. This saves an estimated \$759 per year in filing time.
Daniel R. Toleno	Park and Recreation	\$65	Mr. Toleno is a District Recreation Supervisor in the Recreation Division. He suggested that bulb snatchers be purchased so that employees from the Transportation Department would not have to change bulbs. This saves the City an estimated \$654 per year.
Gary M. Dorsett	Park and Recreation	\$25	Mr. Dorsett is a Groundskeeper in the Park Division. He suggested that a shield be constructed around a sprinkler head at Mission Bay Interchange to keep water from shooting out into traffic. This is an economical shield and should be a significant safety improvement.
Estel J. Weatherson	General Services	\$20	Mr. Weatherson is a Driver I in the Solid Waste Division. He suggested that a mirror be installed on the front of packers to eliminate the blind spot in front. This has been done as a safety improvement.
