
BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$13,583.00 by R. E. Hazard Contracting Co., a corporation, for the CONSTRUCTION OF ROBB FIELD BIKEWAY - SOUTH JETTY IN MISSION BAY PARK BETWEEN ROBB FIELD PARK ROAD AND APPROXIMATELY 2,370 FEET WESTERLY in the City of San Diego, California, is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757211.
2. That the expenditure of \$20,000.00 is hereby authorized out of the Bicycle Lane State Grant Fund (Fund 2720) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF ROBB FIELD BIKEWAY - SOUTH JETTY IN MISSION BAY PARK BETWEEN ROBB FIELD PARK ROAD AND APPROXIMATELY 2,370 FEET WESTERLY in the City of San Diego, and related costs.
