


RESOLUTION No. 217433

BE IT RESOLVED, by the Council of The City of San Diego as follows: *R77-1049*

1. That the bid of \$10,919.00 by Wilcox Electric Inc. dba Arrow Electric, a corporation, for the CONSTRUCTION OF SAFETY LIGHTING ON CREST WAY NORTHERLY OF LA AMATISTA ROAD; ON LA JOLLA MESA DRIVE NORTHERLY OF LAMPLIGHT DRIVE; ON CROWN POINT DRIVE AT KENDALL STREET; ON HENSON STREET NORTHERLY OF SKYLINE DRIVE; AND AT HEALTH CENTER DRIVE AND STARLING DRIVE, including Addendum A, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757212.
2. That the expenditure of \$18,819.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SAFETY LIGHTING ON CREST WAY NORTHERLY OF LA AMATISTA ROAD; ON LA JOLLA MESA DRIVE NORTHERLY OF LAMPLIGHT DRIVE; ON CROWN POINT DRIVE AT KENDALL STREET; ON HENSON STREET NORTHERLY OF SKYLINE DRIVE; AND AT HEALTH CENTER DRIVE AND STARLING DRIVE, including Addendum A, in the City of San Diego, and related costs.
