That the acceptance by the City Manager of that deed of STANLEY E. and JULIA C. POTTER, husband and wife, executed in favor of The City of San Diego, bearing date of September 30, 1976, conveying to said City the permanent easement and right of way for a public sewer or sewers affecting a portion of Lot 1 of Potter Tract, according to Map thereof No. 5386 filed in the Office of the County Recorder of San Diego County, May 11, 1964, as more particularly described in said form of deed, be and the same is hereby approved subject to the conditions therein.

That the expenditure of not to exceed \$15,000 from Sewer Revenue Fund 506 to cover acquisition costs of the above described parcel is hereby authorized.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
