

RESOLUTION No. 217444

Adopted on JAN 5 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That Capital Improvement Construction Fund 244, CIP 31-020, be and it is hereby created.

2. That the City Auditor and Comptroller be and he is hereby authorized to transfer \$50,000 within Capital Outlay Fund Unallocated Reserve, CIP 90-245, to Capital Improvement Construction Fund, CIP 31-020, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for certain improvements to Building No. 2049 at Brown Field for use by the U. S. Border Patrol.

3. That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the improvements to Building No. 2049 at Brown Field, pursuant to the recommendations of the City Manager and the submission of his estimates indicating said work can be done more economically by City Forces than if let by contract.

4. That the Property Department is hereby authorized to negotiate a lease agreement with the U. S. Immigration and Naturalization Service for certain public accommodations at Brown Field.
