WHEREAS, Resolution No. 208763 adopted September 3, 1973, a copy of which is attached hereto as Enclosure (1), urged the Federal Government to relocate its Border Patrol Detention Facility in the San Ysidro community of San Diego to a more appropriate area and authorized the City Manager to initiate discussions with the United States to examine the feasibility of relocation and offer City assistance; and

WHEREAS, relocation has not taken place; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized and directed to renew his efforts to cause a relocation and report back to this City Council concerning these efforts within 90 days hereof.

RESOLUTION NO. 208763 SEP 6 1973

WHEREAS, the United States Border Patrol Detention Facility in San Ysidro was originally constructed in a relatively isolated portion of the San Ysidro community; and

WHEREAS, this facility is presently no longer consistent with the surrounding community; and

WHEREAS, the San Ysidro Community Planning Group and the San Ysidro Elementary School District Board have urged the relocation of the present facility to a more appropriate site; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that said Council urges the federal government to relocate its Border Patrol Detention Facility in San Ysidro to a more appropriate area.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to initiate discussions with the United States federal government to examine the feasibility of said relocation and to offer the assistance of The City of San Diego in this matter.
