BE IT RESOLVED, by the City Council of The City of San Diego, that City Manager Hugh McKinley is hereby requested to personally conduct a complete and thorough inquiry of the Police Department intelligence activities, operations and organization.


BE IT FURTHER RESOLVED, that his personal inquiry should include, among other things:

(1) Personal interviews with past and present City employees who have knowledge of the past and present policies and practices of the Police Department with respect to intelligence activities.

(2) Personal examination of the files of the Police Department that relate to the past and present intelligence activities of the Police Department with the sole exception of "State summary criminal history information."

BE IT FURTHER RESOLVED, that the City Manager is requested to present a comprehensive report to the Council on Police Department intelligence activities indicating his findings and recommendations no later than March 1, 1977, without indicating the specific findings of his inquiry as to actual persons or places or the specifics of any other information gained from confidential police files or sources.
