

RESOLUTION NO. 217461

RESOLUTION CONSIDERING THE PROTESTS AND CONFIRMING THE ASSESSMENTS IN THE MATTER OF THE MARKET STREET LIGHTING DISTRICT AND ANNEXING SAID DISTRICT INTO THE SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1.

WHEREAS, by Resolution of Intention No. 217214, adopted December 8, 1976, declared this Council's intention to order the confirmation of assessments for the Market Street Lighting District for the period ending June 30, 1977, and annex said district into the San Diego Street Lighting Maintenance District No. 1; and

WHEREAS, on the date, time and place set forth in said resolution, a public hearing was held with opportunity being given to those persons desiring to protest; and

WHEREAS, pursuant to Chapter 6, Article V, Division 2 of the San Diego Municipal Code, the Council has considered and reviewed the costs to be assessed for the supplying of energy, maintenance and service for the ensuing year; and

WHEREAS, the proposed assessments for the said maintenance district are on file in the office of the Street Superintendent and have been made available for public inspection; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The assessment district is hereby established and the improvements are hereby ordered.



5. The map of said district is hereby amended by the addition of page 150, which includes the Market Street Lighting District, as shown on the maps of said district on file in the office of the City Clerk as Document Nos. 736783, 740419, 744433, 747772, 751958, and 756083.
