A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE CONSTRUCTION, OPERATION AND MAINTENANCE OF A PUBLIC STREET AND INCIDENTS THERETO, TOGETHER WITH CERTAIN EARTH EXCAVATIONS, EMBANKMENTS, SLOPE OR SLOPES AND A STORM DRAIN OR DRAINS AND APPURTENANCES THERETO, IN PORTIONS OF SECTION 35, TOWNSHIP 18 SOUTH, RANGE 2 WEST, SAN BERNARDINO BASE AND MERIDIAN; PORTIONS OF LOTS A-177, A-178, A-179, A-180, A-181 AND A-182, SAN YSIDRO ADDITION NO. 2; PORTIONS OF LOTS A-211, A-217, A-218, A-219, A-220 AND A-221, SAN YSIDRO ADDITION NO. 4; PORTIONS OF LOTS A-1, A-2, A-3, A-4, A-5, A-81, A-82 AND A-85, SAN YSIDRO; AND PORTIONS OF LOTS A-79, A-80 AND A-81, LITTLE LANDERS SUBDIVISION OF SAN YSIDRO, ACCORDING TO UNITED STATES GOVERNMENT SURVEY, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA; AND THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY DEMAND THE ACQUISITION OF FEE TITLE AND EASEMENTS IN SAID PROPERTY FOR SAID PUBLIC STREET AND INCIDENTS THERETO, TOGETHER WITH CERTAIN EARTH EXCAVATIONS, EMBANKMENTS, SLOPE AND SLOPES AND A STORM DRAIN OR DRAINS AND APPURTENANCES THERETO; AND DECLARING THE INTEN-TION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID PROPERTY AND EASEMENTS UNDER EMINENT DOMAIN PROCEEDINGS; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID PROPERTY AND EASEMENTS.

WHEREAS, the Council of The City of San Diego has provided notice to those persons designated in Section 1245.235, Code of Civil Procedure and also has provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Section 1. That the public interest, convenience and necessity of The City of San Diego, and the inhabitants thereof, require the construction, operation and maintenance of a public street and incidents thereto, together with certain earth excavations, embankments, slope or slopes and a storm drain or drains and appurtenances thereto in portions of Section 35, Township 18 South, Range 2 West, San Bernardino Base and Meridian; portions of Lots A-177, A-178, A-179, A-180, A-181 and A-182, San Ysidro Addition No. 2; portions of Lots A-211, A-217, A-218, A-219, A-220 and A-221 of San Ysidro Addition No. 4; portions of Lots A-1, A-2, A-3, A-4, A-5, A-81, A-82 and A-85 of San Ysidro; and portions of Lots A-79, A-80 and A-81, Little Landers Subdivision of San Ysidro, according to United States Government Survey, as more particularly described hereinafter.

Section 2. That the public interest, convenience and necessity of said City, and the inhabitants thereof, demand the acquisition and taking of fee title and easements in said property for the construction, operation and maintenance of a public street and incidents thereto, together with certain earth excavations, embankments, slope or slopes and a storm drain or drains and appurtenances thereto, and the taking of the surplusage in fee simple, said real property lying within the City of San Diego, County of San Diego, State of California.
