


**RESOLUTION No. 217470**Adopted on JAN 12 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of ROGER A. and CLAIRE R. SANDS, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of November 26, 1976, conveying to said City the permanent easement and right of way for a street and incidents thereto, affecting a portion of Lots 14 and 15, resubdivision of a portion of Rosemont addition to Encanto Heights according to Map thereof No. 1240 recorded March 11, 1910 in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RADIO DRIVE.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
