BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the UNITED STATES OF AMERICA, executed in favor of The City of San Diego, bearing date of March 6, 1975, conveying to said City an easement for the construction, use, maintenance, operation, repair and replacement of a Defense access road and drainage facilities incidental thereto, affecting a portion of Lot 47 of Rosedale Tract Map No. 825 filed in the Office of the County Recorder on January 21, 1897, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the Office of the San Diego County Recorder.
