


RESOLUTION No. 217472Adopted on JAN 18 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the UNITED STATES OF AMERICA, executed in favor of The City of San Diego, bearing date of September 30, 1975, conveying to said City an easement for the construction, use, maintenance, operation, repair and replacement of a Defense access road and drainage facilities incidental thereto, and for underground utility pipelines and appurtenances thereto affecting portions of Lots 48, 50, 51 and 52 of Rosedale Tract according to Map thereof No. 835 filed in the office of the San Diego County Recorder on January 21, 1897, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
