
Adopted on JAN 12 1977

That the City Manager, be and he is hereby authorized and empowered to execute, for and on behalf of said City a novation to agreement with Wilsey and Ham to provide professional engineering services for the design of Rose Creek Bikeway, Phase 1, 2, and 3 in the City of San Diego, under the terms and conditions set forth in the form of novation on file in the office of the City Clerk as Document No. 757953.

BE IT FURTHER RESOLVED, that, pursuant to the terms of said novation and in regard to that certain agreement on file in the office of the City Clerk as Document No. 754206 adopted by Resolution No. 215201 on January 28, 1976, Project Design Consultants, a California corporation is hereby substituted for all rights, duties and obligations of Wilsey and Ham who are hereby released from those obligations to the City of San Diego.
