

RESOLUTION NO. 217478 JAN 12 1977

WHEREAS, fifteen coupons from City of San Diego Harbor Improvement Bonds 1960, 3 1/2 percent, from Bonds Nos. 3271 through 3280 and 3286 through 3290 at \$17.50 each, due May 1, 1976, cannot be found or produced by the custodial bank, Bank of America National Trust and Savings Association; and

WHEREAS, a request has been received to pay \$262.50 in lieu of lost coupons; and

WHEREAS, an indemnity letter has also been received to indemnify the City for possible loss due to making such payment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer is hereby authorized to pay the sum of \$262.50 to Bank of America National Trust and Savings Association, San Diego, in lieu of fifteen coupons due May 1, 1976, which were lost, mislaid, destroyed or stolen, from Bonds Nos. 3271 through 3280 and 3286 through 3290, City of San Diego Harbor Improvement Bonds 1960.

BE IT FURTHER RESOLVED, that the City Treasurer place in the City Treasurer's files the letter of indemnity from Bank of America National Trust and Savings Association dated October 28, 1976.
