
WHEREAS, PLEASURELINE PRODUCTS, INC., dba San Diego Cab Co., is the holder of sixteen (16) certificates of public convenience and necessity to operate taxicabs within the limits of the City of San Diego as heretofore duly authorized by the City Council of The City of San Diego; and

WHEREAS, Section 72.0101(k) of the San Diego Municipal Code provides that said certificates may be suspended or revoked by the City Council at any time when the holder of said certificates has ceased to operate the taxicabs to which the certificates apply for a period of thirty (30) consecutive days without having obtained permission for cessation of such operation from the City Council; and

WHEREAS, Pleasureline Products, Inc., dba San Diego Cab Co., has not operated the taxicabs to which the certificates apply since August, 1976 and has not heretofore received permission for cessation of such operation from the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that pursuant to Section 72.0101(k) of the San Diego Municipal Code, the sixteen (16) certificates of public convenience and necessity to operate taxicabs heretofore issued to Pleasureline Products, Inc., dba San Diego Cab Co., be and they are hereby revoked effective on the date of adoption of this resolution.
