

RESOLUTION NO. 217493 JAN 12 1977

WHEREAS, The City of San Diego presently maintains a radio transmission facility atop Mt. Woodson; and

WHEREAS, the State of California owns Mt. Woodson and has indicated that it intends to sell the mountain to the highest bidder, including the portion of the property occupied under lease from the State by the City of San Diego; and

WHEREAS, in the interest of the public health, safety and welfare of the people of the City of San Diego and the State of California, it is necessary that the City have a permanent right to maintain a radio transmission facility atop Mt. Woodson, near Ramona, in the County of San Diego;

NOW, THEREFORE,

BE IT RESOLVED, that the City Council of The City of San Diego, hereby officially requests that the State retain ownership of the Mt. Woodson mountaintop together with the right of access thereto.

BE IT FURTHER RESOLVED, that in the event the State of California determines not to retain ownership of Mt. Woodson that The City of San Diego be granted an option to purchase the property.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to communicate this request to the


