


RESOLUTION No. 217496 R. 77-1317

BE IT RESOLVED, by the Council of The City of San Diego as follows:

There is hereby established a Task Force consisting of a member of the City Attorney's staff, the City Manager, City Clerk, and the Rules Committee Consultant, Coleman Conrad, to review the Clerk's Office in terms of its functional capabilities and the workload requirements that it now has, not only in terms of the data retrieval system, but also its other responsibilities that relate to Council business--tracking information and processing information--to determine whether or not it is today capable, in terms of how it has been organized and staffed, to provide the kinds of service levels the Council is demanding of it.
