

RESOLUTION NO. 217518 JAN 19 1977

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of VIEWPOINT DRIVE has been relocated by the approval on this date of the dedication of Viewpoint Court by the acceptance of the final map of the subdivision to be known as BAY TERRACE GREENS; and

WHEREAS, those properties adjoining that portion of Viewpoint Drive to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the subdivision to be known as Bay Terrace Greens; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of VIEWPOINT DRIVE, as more particularly shown on Drawing No. 13821-B on file in the office of the City Clerk as Document No. 758016, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
