RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA,  
DIRECTING CLERK TO GIVE NOTICE INVITING SEALED BIDS AND PROPOSALS  
FOR CONSTRUCTION WORK

(Palm Avenue Assessment District)

WHEREAS, the Council of The City of San Diego adopted its Resolution of Intention, Resolution No. 217521, declaring its intention to order the work and improvements therein referred to; and

Pursuant to the provisions of the Improvement Act of 1913, the Council of the City of San Diego hereby invites sealed bids and proposals for doing the work and improvements described in those certain plans, specifications, drawings, cross-sections and estimates contained in The Report of The City Manager, Document No. 758012, approved by Resolution No. 217522, and referred to in Resolution of Intention No. 217521 and other documents duly adopted therefor by the City Council, to which documents and resolutions reference is hereby made for a description of the work and improvements. Said resolutions and plans, specifications, drawings and estimates are hereby referred to for a description of the work and improvements, the grades to which, and rights-of-way within which, it is to be done, a description of the district to be assessed to pay the costs and expenses thereof, and for all further particulars.

The proceedings for said work and improvements and the construction contract shall be under and in accordance with the Improvement Act of 1913.

NOTICE IS FURTHER GIVEN that the Council has ascertained and declared by the adoption of Resolution No. 215808 on April 21, 1976, and on file in the office of the City Clerk, the

prevailing rate and scale for wages in accordance with law to be paid in the construction of the above-entitled improvements. Said rates and scales are by reference incorporated herein and made a part of this notice.

The City Council reserves the right to reject any and all bids and proposals, and to the extent permitted by law, to waive any irregularity in any bid or proposal.

Each bid or proposal shall be accompanied by cash, or a check payable to the order of the City of San Diego certified by a responsible bank, or a cashier's check, for an amount not less than ten per cent (10%) of the aggregate of the proposal, or a bond as required by Section 10502 of the Streets and Highways Code.

The bids and proposals shall be presented to the Purchasing Agent of the City of San Diego at his office in City Operations Building, 1222 First Avenue, in the City of San Diego, on or before 11:00 a.m. on March 9, 1977.

Bids and proposals will be opened by the Purchasing Agent at a public meeting in Conference Room No. 2 on the Second Floor of the said City Operations Building, at the hour of 11:00 a.m. on March 9, 1977, and he shall report the results of the bidding to the City Council at its next regular meeting after the opening.
