

RESOLUTION No. 217525Adopted on JAN 19 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of GERALDINE J. TURNER, a trustee of the Geraldine J. Turner Trust, executed in favor of The City of San Diego, bearing date of October 27, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across Lot 11 and a portion of Lot 10, Block 16, Sorrento Lands and Townsite according to Map thereof No. 483 filed in the office of the County Recorder, February 9, 1888, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SORRENTO VALLEY ROAD.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
