


**RESOLUTION No. 217532**Adopted on JAN 19 1977

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with ELEMENTARY INSTITUTE OF SCIENCE, a nonprofit corporation, leasing a two bedroom dwelling at 608 51st Street with adjoining vacant lot to the north, for the purpose of developing interests in science careers among children ages 8-18, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 758023.
