
**RESOLUTION No. 217533**Adopted on JAN 19 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Amendment to Permit Agreement granting permission to THE SAN DIEGO POLICE OFFICERS' ASSOCIATION to use approximately 2,500 square feet of floor space just east of the jail and directly below the gymnasium for the purpose of operating a cafeteria for Police Department personnel, for one year commencing April 1, 1977, providing for yearly renewals thereafter at the option of the City Manager, as set forth in the form of Amendment to Permit Agreement on file in the office of the City Clerk as Document No. 758024.

BE IT FURTHER RESOLVED, that the requirements of Council Policy 700-10 are hereby waived.
