


RESOLUTION No. 217535Adopted on JAN 19 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PAUL E. and BONNIE J. PEARSON, husband and wife, executed in favor of The City of San Diego, bearing date of October 25, 1976, conveying to said City an easement for a right of way for a public street and incidents thereto, through, over, under, upon, along and across a portion of Lot 7 in Block 1 of Bay View Addition, according to Map thereof No. 271 filed in the Office of the County Recorder of San Diego County, July 23, 1887, as more particularly described in said deed be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named GAINES STREET.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
