RESOLUTION NO. 217539 JAN 19 1977

WHEREAS, the City Council has determined that it is in the best interest of the City and its citizens that the United States Department of the Navy reconstruct its Naval Hospital on a site within the City of San Diego; and

WHEREAS, because of the many benefits which would accrue to the City and its citizens from the reconstruction and operation of such a Naval Hospital, it is the City's intention to cooperate with the Department of Navy's effort to accomplish such reconstruction, NOW, THEREFORE,

BE IT RESOLVED, that the City Council hereby authorizes and directs the City Manager to assist the United States Department of the Navy in finding and acquiring a suitable site for the reconstruction of the Balboa Naval Hospital.

BE IT FURTHER RESOLVED, that the City Council, subject to approval by the voters pursuant to the City Charter, hereby approves such reconstruction in Balboa Park on a site easterly and northerly of the Navy's existing site.

BE IT FURTHER RESOLVED, that in the event the voters fail to approve an exchange of property within Balboa Park in order to accomodate reconstruction, the City Council hereby directs the City Manager to cooperate with and assist the Navy in finding and acquiring a suitable site within the City.
