BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Del Sur Boulevard, adjacent and contiguous to Lots 3 and 4, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

MICROFILMED MAY 3 1 1978 BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction of sewer facilities, and the access easement in Lot 9, with the right of ingress and egress for maintenance of the public sewer facilities within said Lot, designated as "ACCESS EASEMENT GRANTED HEREON," all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street and portion of a street are accepted on behalf of the public as heretofore stated; that that certain easement with the right of ingress and egress for the construction of sewer facilities; and that access easement as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.
