APPROVING MAP OF CORONADO HIGHLANDS UNIT NO. 1 RESUBDIVISION  
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF  
COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by  
J. EDWARD ROBERTS, JR., a Registered Civil Engineer, and entitled  
"CORONADO HIGHLANDS UNIT NO. 1 RESUBDIVISION Being a subdivision  
of Lots 1, 2 and 3 of Coronado Highlands Unit No. 1, in the City of  
San Diego, County of San Diego, State of California, according to  
Map thereof No. 7551, filed in the office of the County Recorder  
of San Diego County, February 15, 1973, together with Elm Avenue  
as dedicated to public use and Raedel Drive and Raedel Court as  
closed and vacated to public use.", is made in the manner and  
form prescribed by law and conforms to the surrounding surveys;  
that said map and the subdivision of land shown thereon is hereby  
approved and accepted; and said Council hereby accepts on behalf  
of the public, the following: Raedel Drive and Barsanti Court, for  
public purposes; and said streets are hereby declared to be public  
streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on  
behalf of The City of San Diego, a municipal corporation, any  
and all abutters' rights of access in and to Nineteenth Street,  
adjacent and contiguous to Lots 39 and 40, all as shown on this  
map within this subdivision and subject to the conditions set forth  
thereon.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, LARWIN-SOUTHERN CALIFORNIA, INC., that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 751410, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of CORONADO HIGHLANDS UNIT NO. 1 RESUBDIVISION.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
