WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where those streets to be vacated have been superseded by relocation; and

WHEREAS, RAEDEL COURT and RAEDAL DRIVE have been relocated by the approval on this date of the dedication of Barsanti Court and a new alignment for Raedel Drive by the acceptance of the final map of the subdivision to be known as Coronado Highlands Unit No. 1 Resubdivision; and

WHEREAS, those properties adjoining Raedel Court and Raedel Drive to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as Coronado Highlands Unit No. 1 Resubdivision; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That RAEDEL COURT and RAEDEL DRIVE, as more particularly shown on Drawing No. 16899-D on file in the office of the City Clerk as Document No. 758150, which said drawing is attached hereto and made a part hereof, be and the same are hereby ordered vacated.
