


**RESOLUTION No. 217568**Adopted on JAN 26 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, a California corporation, executed in favor of The City of San Diego, dated October 21, 1976, conveying to said City for street purposes a portion of Lot 19, Block 5, Resubdivision of Crittenden's Addition, according to Map thereof No. 889 filed in the office of the County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named UNIVERSITY AVENUE.
