RESOLUTION REQUESTING ALLOCATION OF \$1,584,000 IN STATE PARTICIPATING FUNDS FOR RECONSTRUCTION OF THE GRADE SEPARATION ON HARBOR DRIVE AT THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY TRACKS; DECLARING THAT ALL MATTERS PREREQUISITE TO AWARD OF A CONSTRUCTION CONTRACT HAVE BEEN COMPLETED; AND DECLARING THAT NECESSARY CITY MATCHING FUNDS ARE AVAILABLE.

WHEREAS, The City of San Diego has proposed reconstruction of the grade separation on Harbor Drive at The Atchison, Topeka and Santa Fe Railway Company tracks; and

WHEREAS, it is required that the City furnish evidence to the California Highway Commission that sufficient funds are available for the City's portion of the proposed work before an allocation of State funds is made; and

WHEREAS, said City certifies that all requirements of Section 2456 of the Streets and Highways Code have been met, that Public Utilities Commission orders have been issued, necessary railroad agreements have been executed, sufficient local agency funds are available, and all other matters prerequisite to awarding the construction contract can be accomplished within six months after allocation is made; and

WHEREAS, the cost of the grade separation is estimated as follows:

Mobilization	55,000
Bridge construction and contingency	1,834,000

WHEREAS, the amount of said total cost which is to be shared by the participating agencies is as follows:

State of California	\$1,584,000
The City of San Diego	\$ 198,000
The AT&SF Railway Company	\$ 198,000

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the California Highway Commission is requested to allocate \$1,584,000 in State funds under the provisions of Section 190 of the California Streets and Highways Code for the reconstruction of the aforementioned grade separation in accordance with the aforesaid provisions and detailed information is being submitted to the California Highway Commission by the City through the State Department of Transportation.

2. That pursuant to the California Streets and Highways Code, Section 2456, all conditions precedent to the allocation of construction costs including all necessary orders of the Public Utilities Commission have been executed, all necessary agreements with the affected railway company have been executed, all environmental approvals have been obtained, and all other matters prerequisite to the award of a construction contract can be accomplished within six months after the allocation.

3. That sufficient funds are reserved to cover the City's portion of the proposed work for reconstruction of the aforementioned grade separation under CIP No. 52-203 and scheduled
